Please refer to your application dated 02.07.2018, received from Commandant 7th Bn. PAP Jalandhar vide his office memo No.10522/CA dated 10.07.2018, on the subject cited above.

That the State of Punjab vide notification dated 07.06.2016, issued under sub section 4 of section 24 of RTI Act 2005, has notified that the provisions of RTI Act-2005 shall not apply to Punjab Armed Police, Commando and India Reserve Battalions. As per proviso to sub section 4 of section 24 of the Act, if the information demanded pertains to allegations of corruption and human rights violations, then in that case, such information can not be refused on the grounds of such notification issued by the Central Govt. or State Govt.

In the light of the above mentioned facts, your RTI application, has been declined/rejected on the grounds of notification, as mentioned above.
