Please refer to your application dated 28.07.2018, on the subject cited above.

That the State of Punjab vide notification dated 07.06.2016, issued under sub section 4 of section 24 of RTI Act 2005, has notified that the provisions of RTI Act-2005 shall not apply to Punjab Armed Police, Commando and India Reserve Battalions. As per proviso to sub section 4 of section 24 of the Act, if the information demanded pertains to allegations of corruption and human rights violations, then in that case, such information can not be refused on the grounds of such notification issued by the Central Govt. or State Govt.

It is also relevant to mention here that as per sub section (3) of section 8 of the RTI Act, 2005, there will be no obligation to give any citizen any information relating to any occurrence, event or matter which had been taken place, occurred or happened 20 year before the date on which any request is made under this Act. You have demanded an information pertaining to the B-I test held in the year 1993, the test was held about 25 year ago. Hence, from that point of view also, your application is legally suitable for refusal.

In the light of the above mentioned facts, your RTI application, has been declined/rejected as mentioned above.
